ISCC aims at the implementation of highest sustainability requirements in terms of ecological sustainability, social sustainability, compliance with laws and international treaties, monitoring of greenhouse gas (GHG) emissions and good management practices.



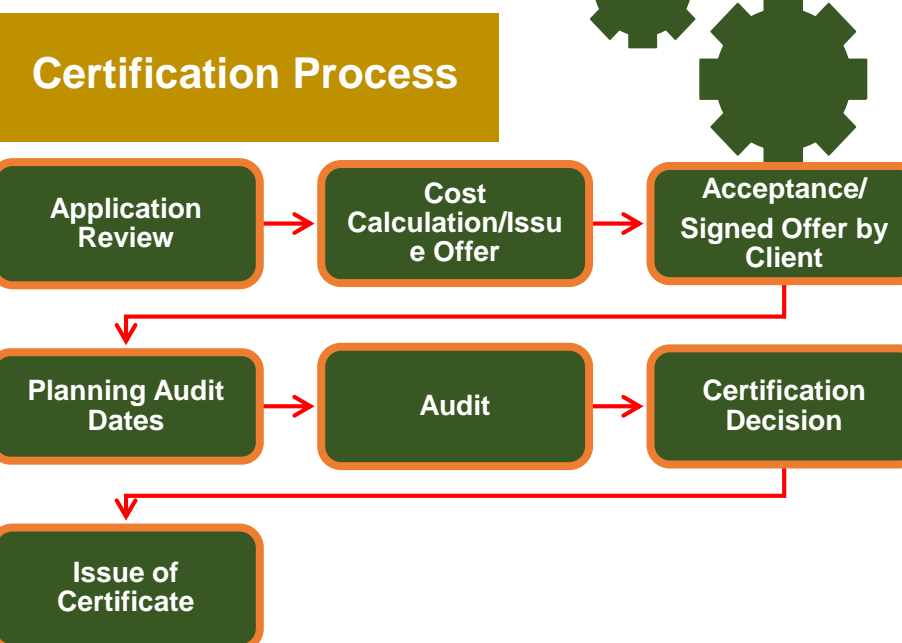
The 6 Principles of the ISCC EU 202 Agricultural Biomass

The MSPO Standards contains seven (7) principles which form the general requirements of a management system framework, based on the three pillars of sustainability; economically viable, socially acceptable, and environmentally sound. The general requirements are as follow:

Principle 1	Protection of Land with High Biodiversity Value or High Carbon Stock
Principle 2	Environmentally Responsible Production to Protect Soil, Water and Air
Principle 3	Safe Working Conditions
Principle 4	Compliance with Human, Labour and Land Rights
Principle 5	Compliance with Laws and International Treaties
Principle 6	Good Management Practices and Continuous Improvement.

GGC offers two certification systems. Application depending on the market:

1. ISCC EU – Applicable for sustainable fuels used in the EU. To demonstrate compliance with the EU's sustainability criteria for biofuels set out in the RED II.
2. ISCC Plus – Application for voluntary and certain regulated markets:
 - Energy & Biofuels Outside the EU
 - Industrial Applications
 - Food & Feed Markets
